Award of the IOI's Elisabeth Mann Borgese Medal to Karmenu Vella - European Commissioner for Environment, Maritime Affairs and Fisheries

Malta, 2nd December 2019

The Elisabeth Mann Borgese Medal was conferred on Commissioner Vella in appreciation of his enduring commitment to bringing the seas and oceans to the forefront of the European and global agendas throughout his tenure as European Commissioner for the Environment, Maritime Affairs and Fisheries (2014-2019). The medal recognizes leadership in promoting the importance of sustainable maritime occupations and economies that preserve natural resources on land and sea and, especially, for creating and maintaining global partnerships aimed at good governance of our planet's ocean. The IOI recognises and appreciates the support to the IOI as custodian of the legacy of Elisabeth Mann Borgese and Arvid Pardo.

The award ceremony was held at Europe House, in Valletta, Malta. Present at the ceremony were Awni Behnam, Honorary President of the IOI; Antonella Vassallo, Managing Director of IOI HQ; Ocean Ambassador Alan Deidun, Director of the IOI Malta Training Centre as well as the distinguished speakers present during the seminar. The celebration was also attended by the participants and faculty of the 15th IOI Training Programme on Regional Ocean Governance for the Mediterranean, Black, Baltic and Caspian Seas.

15th IOI Training Programme on Regional Ocean Governance for the Mediterranean, Black, Baltic & Caspian Seas Malta, 4th November – 6th December 2019

The 15th edition of the annual five-week Training Programme on Regional Ocean Governance for the Mediterranean, Black, Baltic and Caspian Seas held in Malta was inaugurated through a ceremony presided over by Awni Behnam, Antonella Vassallo and Alan Deidun. The keynote speech was delivered by Karmenu Vella, Commissioner for the Environment, Maritime Affairs and Fisheries. A video message by UN Special Envoy for the Ocean Ambassador Peter Thomson and a briefing by University Pro-Rector Godfrey Baldacchino followed. Other distinguished guests at the ceremony included the German Ambassador to Malta His Excellency Walter Haßmann, representatives from the Egyptian Embassy and Francesca Gatt from the Ministry for Foreign Affairs and Trade Promotion (MFTP). The German government actively supports the IOI Malta Training Course through DAAD (the German Academic Exchange Service).

During the opening ceremony a special video message created with the help of past IOI alumni was also launched, giving a small glimpse to the participants of the opportunities that they too may have once they complete an IOI Training Programme (full video available on page 7).

This year's 21 participants hailed from 12 countries surrounding the regional seas: Morocco, Algeria, Egypt, Germany, Ukraine, Russia, Georgia, Spain, Croatia, France, Malta and PR China. As in previous years, the participants came from diverse academic and professional backgrounds, ranging from coastal and marine management to engineering, hydrology and aquaculture management.

As in previous years, the 2019 Malta Training Programme gave the participants the unique opportunity to obtain formal accreditation by the University of Malta for the academic content of the Course by completing and submitting the full Study Unit assessments. Successful achievement of the accredited Study Units was equivalent to 15 ECTS from the University of Malta, host institute of the IOI Malta Training Centre.

As well as the usual format of class-based lectures, the participants also engaged in policy-simulation sessions, role-playing games, scenario planning and mock meetings which allowed them to use their knowledge and skills in a more practical and multidisciplinary manner. Similarly to previous training programmes, the learning experience was not limited to the classroom, with two fieldtrips showcasing areas of significant marine and coastal importance around Malta and Gozo such as the Grand Harbour, the National Aquarium, Xrobb I-Ghagin Nature Park, Wied il-Mielah limestone natural arch, Dwejra coastal protected area and the Marsalforn Salt Pans.

The course culminated with the Regional Ocean Policy Frameworks Simulation exercise for the Mediterranean, Black, Caspian and Baltic Seas, by now an established hallmark of the course where participants have the opportunity to engage in the process of policy drafting under the guidance of regional experts that encouraged them to use the knowledge gained during the programme in a practical application of policy making and governance. During the closing ceremony that followed shortly after, H.E. Ms Nada Draz, Ambassador for Egypt, handed out the course completion certificates to the participants, marking thus the end of the 2019 Training Programme.

The 15th edition of the training programme was once again ably directed by Dr Awni Behnam. Prof Alan Deidun was Course Manager, expertly aided by the course administration team comprised of Celine Farrugia and Tania Aquilina.

IOI Special Seminar on

Challenges of area-based management tools (ABMTs)
in areas beyond national jurisdiction (BBNJ):
"Discussions on Areas beyond national jurisdiction (BBNJ) under UNCLOS"

Valletta, Malta, 2nd December 2019

On Monday 2nd December, the annual IOI Special Seminar was held at Europe House, Valletta, with the support and collaboration of the European Commission Representation in Malta. The seminar was held within the IOI's 15th Training Programme on Regional Ocean Governance for the

Mediterranean, Black, Baltic and Caspian Seas.

Awni Behnam, Antonella Vassallo and Alan Deidun delivered the opening remarks and set the stage for the speakers that followed: David Johnson (Director, Seascape Consultants Ltd and Former Executive Secretary to the OSPAR Commission) addressed the modalities of protecting the High Seas and designating areas as MPAs, expanding on the lessons learnt from

establishing the Charlie Gibbs MPA; Anila Premti (Associate Legal Officer, Policy and Legislation Section, TLB, Division on Technology and Logistics, UNCTAD, Palais des Nations) delivered a presentation on the challenges of ABMTs in areas beyond national jurisdiction while also offering special perspectives on navigation, maritime routes, trade and development; Liliana Rodrigues Cortes (IOI Representative in New York) expanded on the discussions currently underway at the UN on ABMTs in ABNJ while further highlighting what state actors, civil society, NGOs and other groupings wish to achieve in the discussions. Karmenu Vella (European Commissioner for Environment, Maritime Affairs and Fisheries 2014-2019) analysed the issue at hand from the prism of the aspirations, perspectives and experiences of the Commission and the EU during the negotiations.

The seminar drew to a close with the presentation of a statement from Sofia Sadogurska, representative of the class of 2019 of the IOI Training Programme on Regional Ocean Governance for the Mediterranean, Black, Baltic & Caspian Seas:

"we URGE for determined action at an international scale to save our oceans. There is a lack of sound, effective global biodiversity governance in Areas Beyond National Jurisdiction, which comprise over half of the world ocean.

We, as the new generation of ocean ambassadors, are unable to address this issue due to the existing governance deficit. Therefore, the development of a new international agreement for the conservation and sustainable use of biodiversity is now a priority for all of us.

Finally, we remember that we stand on the shoulders of giants such as Arvid Pardo and Elisabeth Mann Borgese, who were at the very beginning of the conception of "the common heritage of humankind" for High Seas. As participants of the IOI Training Programme on Regional Ocean Governance, we can now say we have also taken on board their legacy on a personal level.

Nonetheless, it is all our collective responsibility to act as ambassadors and promoters of sustainable ocean for the sake of generations to come. We will do our best, but we cannot do much without legal framework in place.

Report from the 2019 Danielle de St Jorre Scholarship awardee

Since 2000 the IOI has awarded an annual scholarship to one woman from a Small Island Developing State (SIDS) involved in marine related activities to improve her knowledge of the subject by helping fund participation in the IOI's Training Programme on Ocean Governance: Policy, Law and Management (Canada, 20th May to 17th July 2020). This scholarship was established to honour the memory of the late Danielle de St Jorre, Minister for Foreign Affairs, the Environment and Tourism of the Republic of the Seychelles and a member of the IOI Governing Board, in consideration of all she did in her short life for the benefit of her country, the small island developing states and the world at large.
